

Subject: Launch of a special drive to issue ration cards to the weakest section of society


Madam /Sir,

NFSA, 2013 was enacted with the objective of providing food and nutritional security in human life cycle approach by ensuring access to adequate quantity of quality food at affordable prices to people to live a life with dignity. Accordingly, eligible beneficiaries under the categories of Antodaya Anna Yojana and Priority Households are entitled to receive 35 kg of foodgrains per family per month and 5 kg per person per month respectively at a highly subsidized rate of Rs 3/2/1/- per kg of rice/wheat/ coarse grains or combination thereof.

2. NFSA, 2013 provides for coverage of upto 75% of rural population and 50% of urban population at the all India level. Food grains are, however, provided to beneficiaries on the production of Ration Card only issued to them. The process of issuing ration cards has been made 'on line' by States/UTs. However, it is felt that some of the poor people may not be aware enough about the procedure to procure a ration card owing to a number of reasons and may find it difficult to comply with the procedural requirements. It is necessary, therefore, to have a pro-active approach to reaching out to the most vulnerable and economically weakest sections of the population .

3. States/UTs are requested to launch a special drive during 25th November, 2017 to 31st January, 2018 to identify such persons and issue them ration card, so that the objective of NFSA, 2013 is fully achieved.
