

Notification

No. Pra.06/Vividh-49/2013 / In exercise of the powers conferred by sub section (1) of section 10 of the National Food Security Act, 2013 the Government of Bihar hereby makes the following guidelines to identify the eligible households to cover under Targeted Public Distribution System within the number of persons determined under section 9 of the said Act for the rural and urban areas of the State .

1. The households of the following categories will not be in the categories of eligible households under National Food Security Act, 2013 :-

(A) **In Rural Area**

- I. Households owning motorized three/four wheelers. OR
- II. Households owning mechanized three/four wheeler agricultural equipments . OR
- III. Households with any member as Government Employee*. OR
- IV. Households with non-agricultural enterprises registered with Government OR
- V. Households with any member earning more than Rs. 10,000 P.M .OR
- VI. Households paying income tax . OR
- VII. Households paying professional tax . OR
- VIII. Households with three or more rooms with pucca walls and pucca roof. OR

- IX Households owning 2.5 acres or more irrigated land with at least one irrigation equipment . OR
- X. Households owning 5 acres or more land irrigated for two or more crop seasons. OR
- XI. Households owning 7.5 acres or more land with at least one irrigation equipment.

(B) In Urban Area

- I. Households owning concrete roof three rooms (Self owned) and more . OR
- II. Households owning following assets :
 - (a) Two wheeler
 - (b) Refrigerator
 - (c) Washing Machine . OR
- III. Households owning four wheeler or AC

2. It has been decided to include the following persons in the categories of eligible households under National Food Security Act, 2013 in urban areas :-

- (a) Beggar/Rag Picker
- (b) Domestic Workers
- (c) Street vendor/cobbler/hawker/other service provider working on street
- (d) Construction worker / plumber / mason /labour/ painter/welder /security guard/coolie and other head load worker
- (e) Sweeper/sanitation worker/mali
- (f) Home based worker/artisan/handicraft workers/tailor
- (g) Transport worker/driver/conductor/helper to drivers and conductors/ rickshaw puller
- (h) Shop worker/assistant/peon in small establishment/helper/delivery assistant / attendant/waiter
- (i) Electrician/mechanic/assembler/repair worker
- (j) Washer man/ chowkidar

3. In urban areas eligible households have to make the following self declaration to be covered under food security :-

- (i) No household member is in a Government job*
- (ii) No household member has a Non-Agriculture enterprise registered with the Government
- (iii) No household member is paying income tax
- (iv) No household is paying professional tax
- (v) No household member is earning an income more than Rs 20,000 per month

*"Govt. Service" - means the service of the employees working in regular pay scale in the Centre and State Government, Public Enterprises, Local Bodies and self - governing Institutions .

4. There will be following guidelines for Identification of households of eligible scheduled caste and scheduled tribes households will be made in rural and urban areas on the basis of principles of guidelines to cover under Targeted Public Distribution System .

Households of following categories of scheduled caste and scheduled tribes households in census based on social, economic and castes will not be eligible for food security :-

- (I) Households paying income tax. OR
- (II) Households with any member as Government Employee* belonging to group I, II and III . OR
- (III) Households paying professional tax .OR
- (IV) Households owning concrete roof three rooms (Self owned) and more

Notwithstanding the above conditions, the group - D employees of state Govt. will be considered eligible .

*"Govt. Service" - means the service of the employees working in regular pay scale in the Centre and State government, Public Enterprises, Local Bodies and self - governing Institutions .

5. For the coverage of the destitute persons and widows upto age of 45 years in rural and urban areas of the State, there will be following conditions for their eligibilities under the Targeted Public Distribution System :-

(a) Conditions for eligibility of destitute persons :-

- (i) Those destitute persons of all category whose name have not been covered under SECC.
- (ii) Identification of such persons shall be made by Gram Panchayat in rural areas and Municipal Corporation/ Municipality/Nagar Panchayat in urban areas .

(b) Conditions for eligibility of widows

- (i) Widows of all categories upto age 45 years old will be eligible.
- (ii) Widows of all categories upto of 45 years old working government services will not be deemed eligible .
- (iii) Widows of all categories upto age 45 years old paying income tax will not be deemed eligible .
- (iv) Widows of all categories upto age 45 years old of such households owing 2.5 acres or more irrigated land with at

least one irrigation equipment will not be deemed eligible.

- (v) Widows of all categories upto age 45 years old of such households owing 5 acres or more land irrigated for two or more crop seasons will not be deemed eligible .
- (vi) Widows of all categories upto age 45 years old of such households owing 7.5 acres or more land with at least one irrigation equipment will not be deemed eligible .
- (vii) Once selected under the eligibility parameters the widows of the above categories will get the benefits of the scheme after the age of 45 years.


